## **COMMUNICATION FROM MAYOR:**

Re: Meals Tax Order / May 9, 2017

#### Dear Councilors:

I am respectfully vetoing the above-referenced order regarding the imposition of a local options meals tax in the City of Lynn. I am well aware that the City is currently facing a structural deficit in the budget. The Council leadership and I are working diligently to put together a package of measures that will close this deficit at minimum cost to taxpayers, and with an aim to preserve the jobs of all people currently employed by the city. However, I cannot support the creation of a meals tax as one of the remedies to the deficit. Less than two months ago, the citizens of Lynn soundly rejected a tax increase as a way of funding two new middle schools.
